### OFFICE MEMORANDUM

Subject: Preventive Measures to contain the spread of COVID-19 – Brihanmumbai Municipal Corporation (BMC) Order dated 11.06.2021 'Levels of Restrictions for Breaking the Chain' – Regarding.

The undersigned is directed to refer this Department's OM No. 16/6/2020-SCS/COVID-19/Vol.III/6544 dated 07.06.2021 and OM No. 16/6/2020-SCS/COVID-19/Vol.III/6758 dated 11.06.2021 on the captioned subject.

- 2. As per Para-I of GoM Order dated 04.06.2021, Brihanmumbai Municipal Corporation (BMC) is treated as separate Administrative Unit and as per Para-II i.e. 'Levels of Restrictions', the Disaster Management Authority shall enforce the levels of restrictions over Administrative Units falling under its jurisdiction. The Brihanmumbai Municipal Corporation (BMC) vide Order No. MGC/F/4663 dated 11.06.2021 read with BMC Order No. MGC/F/4629 dated 05.06.2021 (copies enclosed) under 'Brake the Chain' have notified that, though the case positivity rate of COVID-19 is 4.40% and oxygen bed occupancy is 27.12% within Brihanmumbai Municipal Corporation (BMC) jurisdiction taking into consideration: (i) The geographical topography and density of population of Mumbai City (ii) Number of people commuting by local trains and (iii) Prediction of heavy rainfall in coming days, the COVID restrictions shall continue to remain under LEVEL-3 category. The above orders of Brihanmumbai Municipal Corporation shall come into force with effect from 14.06.2021 until further orders.
- Till further orders, DAE and its Constituent Units/PSUs/Als located in Brihanmumbai Municipal Corporation jurisdiction are advised to follow the BMC Order dated 11.06.2021 for the purpose of regulation of attendance as per Level-3 category, Also, the Constituent Units/PSUs/Ais located within the State of Maharashtra but outside the jurisdiction of Brihanmumbai Municipal Corporation may follow orders issued by the respective Disaster Management Authorities for regulation of attendance in respect of their employees.
- 4. All "Essential Services" which have been exempted such as Health Care, Fire, Security, Transport etc. shall continue to function with full strength.



### CIRCULAR

Subject: Preventive measures to contain the spread of COVID-19 – Govt. of Maharashtra order dated 04.06.2020 'Levels of Restrictions for Breaking the Chain – reg.

DAE vide OM No. 16/06/2020-SCS/COVID-19/Vol-III/6544 dated 07.06.2021 has forwarded a copy of Government of Maharashtra's Order No. DMU/2020/CR.92/DisM-1, dated 04.06.2021 (Copy enclosed), on the above subject for information and strict compliance until further orders.

- 2. Accordingly, attendance and other aspects will be regulated as per following instructions in BARC, Trombay and all BARC establishments located in the State of Maharashtra.
- 3. The attendance of all Officers/Staff shall be 50% of the total strength everyday. Rest of Officers/Staff shall Work from Home. Heads of Divisions shall prepare roster of employees accordingly.
- 4. Essential services like Fire, Security, Operation & Maintenance, Traffic, Round the clock shift operations, water, electricity, pre-monsoon activities, IT services supporting critical infrastructures and Services shall function with full capacity.
- 5. All Officers and other staff in BARC Hospital and Dispensaries under Medical Division shall function with full capacity.
- 6. Shuttle services will be available at North Gate for commuting within BARC as usual.
- 7. Persons with disabilities and pregnant women employees are exempted from attending office, but they shall continue to work from home, until further orders.
- 8. The Officers/Staff shall follow staggered timings to avoid over-crowding in offices/workplaces as decided by the Heads of Divisions.

- 9. All officials who attend office shall strictly follow Covid-appropriate behavior including wearing of mask, physical distancing, use of sanitizer and frequent hand-washing with soap and water.
- 10. Crowding in lifts, staircases, corridors, common areas, including refreshment kiosk and parking areas is to be strictly avoided.
- 11. Meetings, as far as possible, may continue to be conducted with video-conferencing and personal meetings with visitors, unless absolutely necessary in public interest, are to be avoided.
- 12. In compliance of DoPT OM dated 22.04.2021, all employees of the age of 18 years and above, are advised to get themselves vaccinated.
- 13. Those officers/staff who are working from home on a particular day are to make themselves available on telephone and other electronic means of communications at all times. No employee can claim work from home as a matter of right. In case of any emergency work, any employee can be called for duty and such duty shall not be refused. Those employees who refuse to attend duty when called for, or those who do not respond to phone calls, or other modes of communication, strict action will be taken in such cases.
- 14. The above order will be effective with immediate effect and remain in force until further orders.
- 15. All employees are advised to periodically check BARC web site especially on holidays regarding any updates in the instructions.
- 16. This issues with the approval of Competent Authority.
