1. NIT Details:

Online-Item Rate Tender in two parts i.e., Part A –Techno-commercial Bid and Part B – Financial Bid are hereby invited through e-Tendering mode on behalf of the President of India by Tender Inviting Authority for the following work from eligible contractors. NIT details are as follows:

A part of Earnest Money is acceptable in the form of Bank Guarantee (including e-BG) also. In such case minimum 50% of the Earnest Money or **20.00 Lakhs**, whichever is less, shall be in the form prescribed above and balance can be accepted in the form of Bank Guarantee (including e-BG) issued by a Scheduled Bank as per Appendix 'A' of Tender Part 'A'.

2. Initial Eligibility Criteria:

i) The bidder shall be compliant to the Public Procurement (Preference to Make in India), Order 2017 (as amended from time to time) issued by Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry. In this regard bidder must submit undertaking along with bid for percentage (%) of local content offered in subject tender as per the format shown in Undertaking-3 of this NIT.

ii) Only 'Class-I local supplier' as defined in Public Procurement (Preference to Make in India),

Order 2017, are eligible to participate for subject tender.

- $\ensuremath{\textsc{iii}}\xspace)$ The bidder should have the following :
- (a) Registration in Appropriate Class of Contractors, if any
- (b) Bank Solvency Certificate of a Nationalized Bank / Scheduled Bank for a minimum of **Rs. 56,00,000/-**and should not be older than one year from the date of opening of tender.
- (c) Average Annual Financial Turnover on construction works should be at least Rs 1,40,00,000/during the immediate last 3 consecutive financial years ending 31st March 2023/2024. This should be duly audited by a registered Chartered Accountant and also should have valid Unique Document Identification Number (UDIN) for the practicing Chartered Accountant.
- (d) Should not have incurred any loss in more than two years during last five years ending **31st March 2023/2024**.
- (e) Carried out similar works during last 7 years.
- (f) Performance Certificates.
- (g) Permanent Account Number (PAN) & GST registration Certificate.

The bidder should have satisfactorily completed (based on certification of performance by client of the works) **3 (Three)** similar works each of value not less than **Rs. 56,00,000/-** or **2 (Two)** similar works each of value not less than **Rs. 84,00,000/-** or **1 (One)** similar work of value at least **Rs. 1,12,00,000/-** during the last 7 (Seven) years ending on the last day of the month previous to the one in which the tenders are invited/the works completed up to previous day of the last date of submission of tenders shall also be considered and if the eligible similar works are not carried out in Central Government / State Government / Public Sector Undertaking of Central or State Governments / Central Autonomous bodies, then TDS certificates should be produced by bidder for the same. The cost of completed works as referred in para is inclusive of all taxes but exclusive of GST.

The experience certificate of works completed pre GST era, Completion amount will be divided by 1.12 (to exclude pre GST tax of VAT 12%) to make it at par with experience certificates of post GST era but excluding GST.

For experience certificate of works completed in post GST era, completion cost of work shall be considered excluding GST. If it is not specified in the certificate whether the completion cost is inclusive/ exclusive of GST, an undertaking in this regard shall be submitted by the bidder on their letterhead, duly certified by Chartered Accountant, clearly mentioning that the completion cost is inclusive/ exclusive of GST. In case no such clarification is submitted by the bidders, the cost mentioned in experience certificate shall be deemed to be inclusive of GST and GST component shall be deducted from the same. The value of work arrived after deducting the GST shall only be considered for qualifying requirement as per NIT.

For the purpose, 'cost of work' shall mean gross value of the completed work including the cost of materials supplied by the Govt./Client, but excluding those supplied free of cost. For the purpose of clause Similar Works means "Cosmetic Maintenance Services". The similar works should have been executed in India.

The value of executed works shall be brought to the current costing level by enhancing the actual value of work at simple rate of 7 % per annum, calculated from the date of completion to last date of submission of tenders.

Bidder should be a registered firm in India. Joint Ventures and or Consortiums are notacceptable.

3. Information to Bidders:

Tender document is prepared in two parts viz. Part 'A' (Techno-commercial Bid) and Part 'B' (Financial Bid). Part 'A' consists of Techno-commercial Bid viz. Section I – Notice Inviting e-Tender (English), Section II - Form of Agreement and General Rules and Directions for the guidance of Contractors, Memorandum, Section III – Terms & Conditions of Contract, Section IV – Scope of the work, Appendix 'A'- Form of BG bond for EMD, Appendix 'B' – Form of BG bond for performance security, Undertaking-1 (similar works), Undertaking-2, Undertaking-3 (local content), Undertaking-4 (eligible source countries), Undertaking-5 (Tender Acceptance letter), Undertaking-6 (Undertaking pursuant to the Section 206AB of the Income Tax Act, 1961), Undertaking 7 (GST) all corrigendums to tender documents and Proforma of Schedules 'A' to 'F'. Part 'B' (Financial bid) consists of Schedule 'B' - Schedule of Quantities. All the above documents will form part of Agreement after award of work to the successful bidder.

Guidelines for e-Tendering in CPPP website:

To participate in the Tendering process on the CPP Portal, Prospective Bidders require a valid Class III Digital Signature Certificates. All the documents related to the eligibility criteria of tender should be submitted electronically through CPPP portal only. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

Intending Bidders are advised to visit this website regularly till closing date of submission to keep themselves updated as any change/ modification in the tender will be intimated through this website only by corrigendum / addendum/ amendment.

Assistance to Bidders

Conditions:

- 4. After opening of Part 'A' of tender, Tender Inviting Authority shall constitute a Technical Evaluation Committee which will first verify the online credentials submitted by the bidder with respect to their eligibility for the work and if required, will visit selected work sites of on-going/completed works of the bidders to evaluate the capability of the bidders based on the following.
 - a) Financial capability and their turnover during the last 5 years including Profit/Loss statement.
 - b) Technical capabilities of the company in the light of subject work.
 - c) Nature of works executed by the bidder during last 07 years
 - d) Organizational structure of the company.
 - e) Necessary Resource required by company to carry out the subject work.
 - f) Time & quality consciousness.
 - g) Tendency of the company with regard to making extraneous claims and disputes.
 - h) Site planning ability.
 - i) Tendency of the company to award the work on back to back / subletting.
- 5. No modifications in the tender shall be allowed after opening Part 'A'.

- 6. Tenders with any condition including conditional rebate shall be rejected. However, tenders with unconditional rebate will be accepted.
- 7. If any information furnished by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in BARC. Also if such a violation comes to the notice of Department before start of work, the Engineer-in-charge shall be free to forfeit the entire amount of EMD & Performance Guarantee.
- 8. The time allowed for carrying out the work will be reckoned from the 15th day after date of written order to commence the work or from the first day of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
- 9. Tender will be kept valid for **180 (One hundred eighty) days** from the Last date of closing of online submission of tenders.
- 10. In case the last date of receipt of original document towards EMD and opening of tender are declared as holiday, the respective date shall be treated as postponed to the next working day, correspondingly.
 - 11. Original Demand Draft/Bankers Cheque/Pay Order / Fixed Deposit Receipt / Bank Guarantee (including e-BG), if any of a Scheduled Bank towards Earnest Money Deposit as applicable shall be submitted at aforementioned place, date and time otherwise Tenders are liable to be rejected and will not be processed further.

12. Cheques for Earnest Money Deposit will not be accepted.

13. The contractor whose tender is accepted will be required to furnish by way of security deposit for the due fulfillment of his contract, such sum as will amount to 2.5% of the tendered value of work. In addition, the contractor shall be required to deposit an amount equal to 3% of the tendered value of the contract as Performance Security. Time allowed for submission of Performance Guarantee shall be 15 days from the date of issue of letter of acceptance. Performance Security of 3% to be submitted in the form of Bank guarantees (including e-BG). It can also be accepted in the form of fixed deposit receipts of Scheduled Bank or in the form of Government Securities.

The Performance Guarantee shall be initially valid up to the stipulated date of completion plus 60 days beyond that. In case the time for completion of work gets enlarged, the contractor shall get the validity of performance Guarantee extended to cover such enlarged time for completion of work. After recording of the completion certificate for the work by the competent authority, the performance guarantee shall be returned to the contractor, without any interest.

- 14. The Security Deposit will be collected by deductions @ 5 % of the gross amount of the running bill of the contractors till the total security deposit recovered will amount to 2.5% of the tendered value of work. The Security deposit will also be accepted in the form of Governments Securities, Fixed deposit Receipts of Scheduled Bank and Nationalized Bank. These shall be endorsed in favour of the Pay & Accounts Officer, BARC, Visakhapatnam. Earnest Money Deposit of successful bidder shall be retuned back / refunded on receipt of Performance Security Deposit, however in case Performance Security Deposit is in the form of Bank Guarantee (including e-BG), Earnest Money Deposit will be released subsequent to confirmation of verification of Bank Guarantee from the issuing Bank.
- 15. If the successful tenderer, fails to furnish the prescribed performance guarantee on or before stipulated dates of commencement the department (BARC) shall without prejudice to any other right or remedy, be at liberty to forfeit the said earnest money absolutely.
- 16. The acceptance of tender shall rest with department which does not bind itself to accept the lowest tender and reserves to itself the authority to reject any or all of the tenders received,

without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected.

- 17. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 18. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer-In-charge shall be communicated to the Engineer-In-charge.
- 19. The department reserves the right to accept the whole or only part of the tender and the tenderer shallbe bound to perform the same at the rates quoted.

19. LEVY/TAXES Payable by Contractor:

- i. Any other taxes applicable in respect of inputs or outputs procured by the Contractor for this contract shall be borne by the Contractor and Government will not entertain any claim whatsoever in respect of the same.
- All tendered rates shall be inclusive of all taxes, duties, levy or cess, fee, royalty charges etc.
 levied under any statute but exclusive of GST (Good and Services Tax) applicable on last
 stipulated date of receipt of tender including extension if any.
 No tax liability (other than GST) or insurance expenses will be borne by BARC. GST as
 applicable duly certified by Chartered Accountant on this work contract is reimbursable by
 BARC subject to production of original documentary proof of GST payment for this work.
- iii. An undertaking as per Undertaking-7 of NIT should be submitted for registration under GST and compliance of GST provisions.
- iv. The bidders/ tenders should ensure that they are GST compliant and their quoted tax structure /rates are as per GST Law.
- v. Labour welfare cess @1% of gross value of work done shall be recovered from each bill paid to the contractor.
- vi. Income tax and cess as applicable shall be deducted from each bill paid to the contractor. Contractor should be registered under EPF & ESIC and shall pay EPF & ESIC of contract workers to concerned Department. The bidder should consider EPF & ESIC in his rates.
- vii. Contractors shall comply provisions of the EPF Act, 1952 in respect of all the eligible employees / workers/ labours and submit the documentary proof regularly with every RA Bill.
 Any other taxes /cess as per Government directives shall be deducted from each bill paid to the contractor, from time to time
- 20. Bidder has to submit Undertaking on their letter head pursuant to the Section 206AB (as applicable) of the Income Tax Act, 1961 in prescribed format as enclosed at undertaking-6.
- 21. If any tenderer withdraws his tender within the validity period and before award of work whicheveris earlier or make any modifications in the terms and conditions of the tender which are not acceptable to the department, then the Government shall without prejudice to any right or remedy, beat liberty to forfeit 50 % (Fifty Percent) of the Earnest Money absolutely.

Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.

22. In case of receipt of any adverse charter and antecedent remarks/ notification against the Contractor/ Company/ firm/proprietor and/ or his contract personnel, consequent to the security vetting, BARC reserves absolute right to terminate the contract forthwith without assigning reason/ show cause notice. Under the circumstance the Contractor will have no right to claim good any losses/liability that may be incurred as consequence to the above action initiated by BARC. BARC also reserves the right to forfeit in part/full performance security and/ or security deposit in possession of the Government for failure on the part of the contractor to abide/adhere to the

Security instruction issued by DAE/ BARC from time to time.

Instructions:

- 23. The contractor should be registered with <u>https://eprocure.gov.in/eprocure/app</u>. Those contractors not registered on the website mentioned above, are required to get registered.
- 24. The intending bidder must have valid class-III digital signature for Request for purchase / Download of Tender Document (excel / word formats). The bid can only be submitted/uploaded after providing details of Fixed Deposit Receipts and or Bank Guarantee (including e-BG) of any Scheduled Bank towards Earnest Money Deposit and other documents as specified.
 - 25. Tenders will be received online up to time & date as mentioned in the NIT details above. Part A will be opened on the time & date as mentioned in the NIT details above. The receipt of EMD will be checked first. If found in order, Part 'A' will be opened. After opening of Part 'A', for evaluation, the contractor's Techno-commercial Bid related documents shall be evaluated and accordingly tenderers will be qualified/disqualified by the Competent Authority. The Part 'B' (Financial Bid) of the qualified tenderers shall then be opened at notified date and time. Date of opening of Part 'B' (Financial Bid) will be intimated to all bidders through the CPP Portal website.
 - 26. The EMDs of the unsuccessful bidders will be returned without any interest only after publishing financial evaluation status of bidders on CPP portal.
 - 27. The Financial Proposal/Commercial bid / BoQ format is provided as BoQ_XXXX.xls along with this tender document at <u>https://eprocure.gov.in/eprocure/app</u>. Bidders are advised to download this BoQ_XXXX.xls as it is and quote their offer/rates in the permitted column and upload the same in the commercial bid. All tendered rates quoted in schedule-B shall be inclusive of all taxes, duties, levy or cess, fee, royalty charges etc. levied under any statute but exclusive of GST (Good and Services Tax). Bidder shall not tamper/modify downloaded price bid template in any manner. In case if the same is found to be tampered/modified in any manner, tender will be completely rejected and appropriate action will be taken by department.
 28. On opening date, the contractor can login and see the status of Bids after opening.
- 29. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in SKY BLUE colour. While selecting any of the cells a warning appears to mandatorily fill all such cells with any value, including "0" (ZERO).

Note: Prospective agencies shall satisfy themselves of fulfilling all the NIT criteria before submission of tender. Department reserves the right of non-consideration of tender of the agencies not fulfilling the stipulated criteria.
